BOARDING AND DAY CARE POLICY

- All dogs must have current immunizations against Rabies, Distemper, Parvo Virus, and Bordetella, and Bronchitis.
- All cats must have current immunizations against Rabies, Feline Distemper, Rhinotracheitis, and Calici Virus.
- All animals must have had a Fecal Examination for internal parasites within the last 12 months.
- All dogs must have had a heartworm blood test within the past 12 months.
- All animals must be free of external parasites (fleas & ticks) when admitted for boarding; or must be treated upon admission.
- A cleansing bath is optional on the day of dismissal. All major grooming will be scheduled appropriately with our professional groomer.
- All clients are required to read and sign this boarding policy form.
- Animals will be admitted & discharged ONLY during regular office hours.
- Any animal that requires emergency or immediate veterinary attention will receive it at our discretion, and at the owner's expense.
- An emergency telephone number must be left with the clinic.
- Animals requiring medication or treatment (such as wound treatment) will be charged appropriate
 fees. Heartworm preventive medication should be administered for the month before or after the
 boarding time.
- Your satisfaction and your pet's wellbeing is our primary focus.

I will not hold Lake Chatuge Animal Hospital accountable for any self-inflicted injury my pet may incur while at Lake Chatuge Animal Hospital.

I further realize that I am responsible for the payment of the requested services and any additional services or treatments, that Lake Chatuge Animal Hospital finds necessary to board my pet, in full at the time my pet is discharged. If I neglect to pick up my pet within ten (10) days of communication, that my pet is ready for release, it will be assumed that my pet has been abandoned. In cases of abandonment, I understand that Lake Chatuge Animal Hospital is authorized to re-home my pet as they see fit. Abandonment does not release me financially of my obligation for the services rendered.
